# Conditions of membership

1. All of the Pool rules must be adhered to at all times.
2. Members are expected to volunteer to help with maintenance of the pool and the gardens and with fund raising activities. Committee members will ask for your help from time to time during the year.
3. Members must behave with courtesy and consideration to pool staff, other club members and their guests. Complaints should be addressed to the committee member on duty, who will ensure that information is passed on to the pool duty manager.
4. Membership is open to all adults on payment of the appropriate fee provided that they are prepared to comply with these conditions.
5. All members must present a valid membership card when attending swimming sessions.
6. Children under the age of 18 may not become members. They will be admitted as part of a family provided that the family subscription has been paid. **All children under 8 MUST be accompanied by an adult IN THE WATER** (within easy reach) at all times. No more than two under 8s to each adult.
7. Parents must supervise their children's safety and behaviour at all times.
8. Each member may bring two adults and their children as guests to any club session on the payment of the guest fee. Each guest may visit up to six times in a season.
9. Each adult member (excluding social members) must act as a Poolside & BBQ Club helper a minimum of twice a season which should include one morning and one evening session.
10. Each adult member is encouraged to volunteer at a minimum of two fundraising or awareness raising events, such as the Summer Picnic Concerts.
11. All members, when acting as a Poolside & BBQ Club helper, must report to the duty committee member promptly.
12. Members, their children and guests must not cause a nuisance to other users of the pool (and surrounding grounds), pool staff or Trust members during club sessions. Poolside & BBQ Club helpers are authorised to insist that any person causing a nuisance or disturbing others must leave and this may result in loss of membership (see condition 14).
13. Glass must not be brought onto Pool premises and all areas at the pool and adjacent areas including the car park are non-smoking areas.
14. The Club has the right to refuse or withdraw membership.

## Gift Aid

If you're a UK tax payer you can Gift Aid your donations, making them worth 25 per cent more to us, at no extra cost to you! We can claim back the tax you have paid on your donation (25p for every £1 you donate) through Gift Aid. This additional income really does make a big difference, so please don't forget to Gift Aid donations if you are a UK tax payer.

If you are a higher-rate tax payer you can also claim additional tax relief.

For higher rate tax payers (paying tax at 40%) this works out as 25p for every £1 you donate and for the highest rate tax payers (paying tax at 50%) this works out as 37.5p for every £1 you donate.

## What we need to claim Gift Aid

- A donation made from a personal bank or building society account
- We can't claim Gift Aid on donations from company accounts. The donation must be your own money and not the proceeds of a collection.
- For you to be paying income tax or capital gains tax which at least equals the amount the HPT will claim in the appropriate tax year (6 April one year to 5 April the next). This is currently 25p for every £1 you give.
